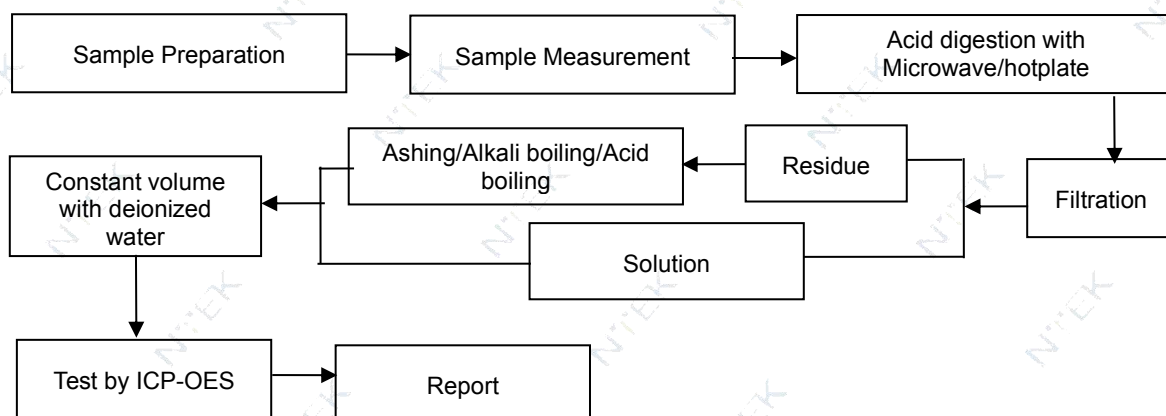

Operation Flow Chart:

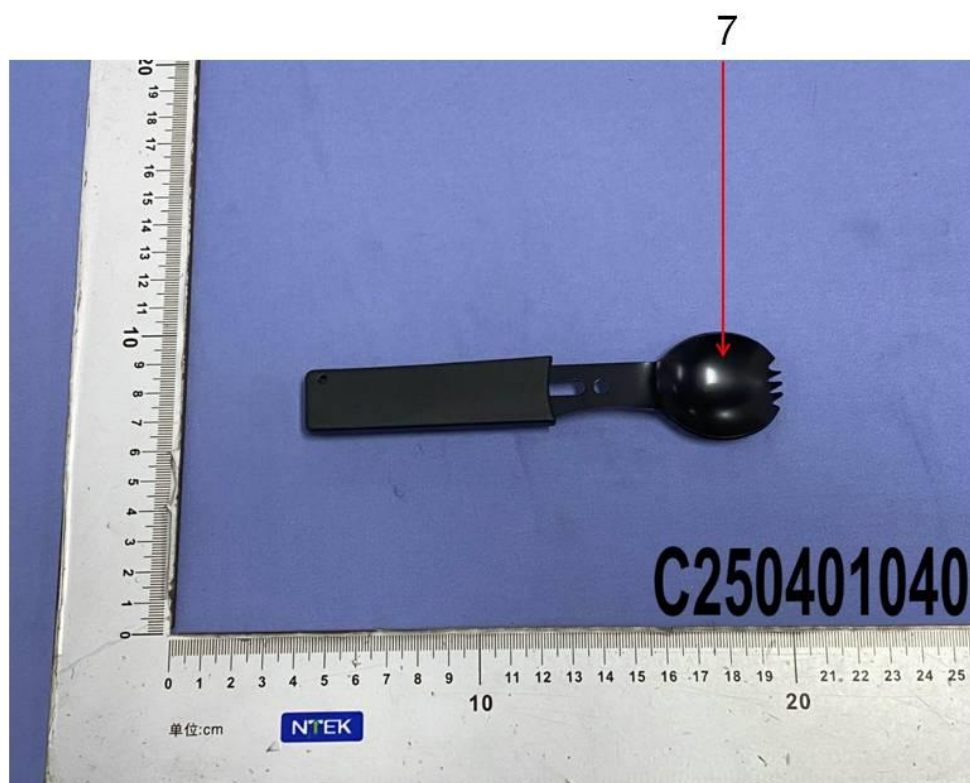
